A proxy will also be entitled to vote at his discretion on any resolution properly put d. to the meeting other than those set out in the notice convening the meeting.

- To be valid, this form of proxy together with any power of attorney or other authority (if any) under which it is signed or a notarially certified copy of such power or authority must be deposited at the offices of the Company's Hong Kong branch registrar, Hong Kong Registrars Limited at Rooms 1712-1716, 17th g. Floor, Hopewell Centre, 183 Queen's Road East, Hong Kong not later than 24 hours before the time of the meeting or any adjourned meeting.
